FUTURE PERMITTING & PUBLIC INVOLVEMENT

The Aroostook Renewable Gateway requires various types of approvals from municipalities, state government, and the U.S. Army Corps of Engineers, the application procedures for which provide opportunities for public review and engagement. A list of the major permits required for the Project is provided below. Written comments may be submitted to municipalities crossed by the Project or governmental permitting agencies at any time. However, the most effective approach is to submit written comments to municipalities and/or agencies during the formal public comment periods, in response to public notices regarding pending permit applications.
